2) 2nd and subsequent shipments, via next day air will be at a fee of \$_____.

3) Semen will be sent in a "disposable" box or equitaner. Mare owner is responsible for the prompt return of the container via priority mail or UPS ground.

PRIOR TO SHIPMENT

1) Notify Justin Gill as soon as the mare foals or comes into heat. Please give a minimum of 2 day notice prior to shipment).

2) All fees are to be paid in full before semen will shipped.

3) A copy of the mare's registration papers is to be sent with the signed contract to Justin Gill.

GUARANTEES

1) In the case of dead or poor semen quality, JG Ranch will send the next shipment at no charge to the mare owner. Justin Gill must be notified

immediately in this case by a veterinarian or technician

2) A live foal guarantee allows that the foal will get up and suck in the first 2 hours of life of foal.

3) In the case the stallion dies or becomes sterile, GILL will offer refund of the stud fee except for booking and collection fee that have been paid in full.

4) In the case the contracted mare dies or is declared unbreedable, a substitute mare will be accepted during this contract year or the following year of _____.

5) Boarding mares must be halter broke and will go in breeding chute in case of injury to mare of mares neglect mare owner is responsible for veterinarian bill.

LEGAL AGREEMENT

1) In the case of any disputes or breach of this contract Texas law will preside as this is a Texas sale, therefore any legal action will be governed by Texas laws and dealt with in a Hockley County, Texas court of law.

2) It is also agreed that in the case of any litigation, if judgment is in favor of GILL, all of GILL'S legal fees will be paid by the mare owner/opposing party.

3) I agree that these 2 copies are exact and am signing both and returning one copy with fees and paperwork to Gill, at which point this becomes a binding contract.
